UNIT OVERVIEW

HLTAID009 - Provide cardiopulmonary resuscitation

This unit describes the skills and knowledge required to perform cardiopulmonary resuscitation (CPR) in line with the Australian Resuscitation Council (ARC). The unit applies to all persons who may be required to provide a first aid response in a range of situations, including community and workplace settings.

This unit covers the following:

- Response to an emergency situation
- Perform CPR procedures
- Communicate details of an incident
- Review an incident

Knowledge Evidence examples: Knowledge of state/territory regulations, first aid codes of practice and workplace procedures; relevant ARC guidelines to managing the unconscious breathing and non-breathing casualty and provision of CPR; techniques for providing CPR to adults, children and infants; duty of care requirements; infection control procedures, including use of standard precautions and resuscitation barrier devices.

Performance Evidence examples: Students must perform at least 2 minutes of uninterrupted single rescuer cardiopulmonary resuscitation (CPR) (5 cycles of both compressions and ventilations) on an adult resuscitation manikin on the floor; perform at least 2 minutes of uninterrupted single rescuer CPR (5 cycles both compressions and ventilations) on an infant resuscitation manikin placed on a firm surface.

IMPORTANT: Learners must be physically capable of bending and kneeling to provide first aid to a person on the floor. This includes performing CPR for a specific amount of time on the manikins.
